

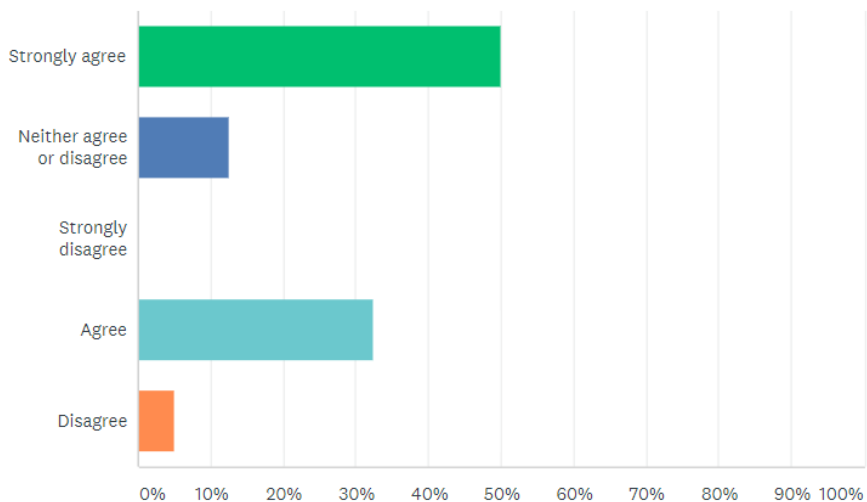


Parental Questionnaire

The school's provision for remote education is effective.

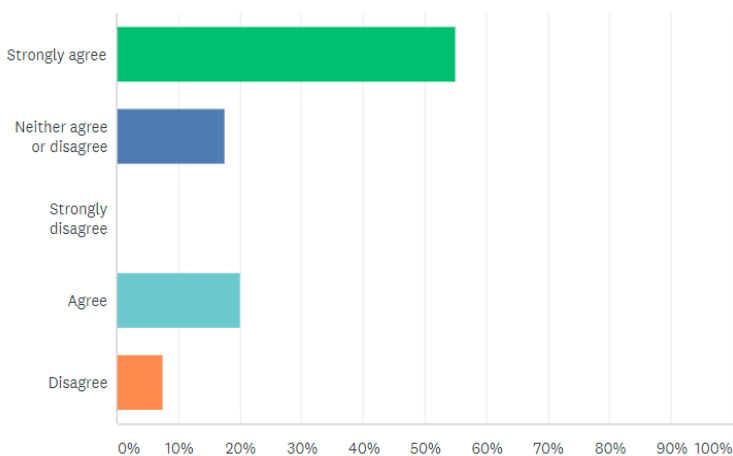

The quality of teaching and learning through remote education is good.

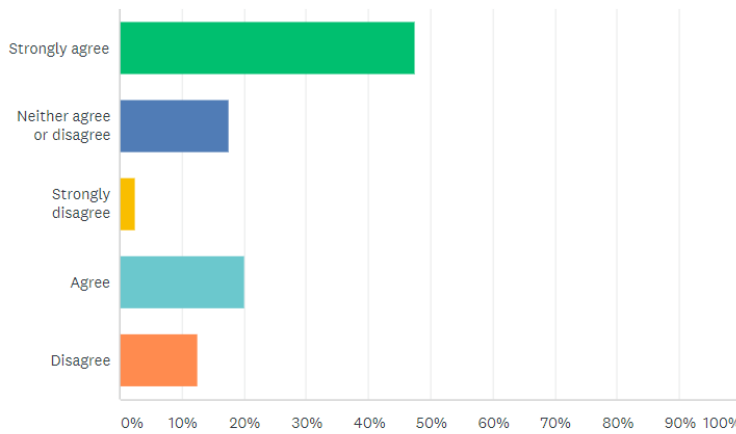

There was a good balance between video lessons, 'live' lessons, paper and online resources.

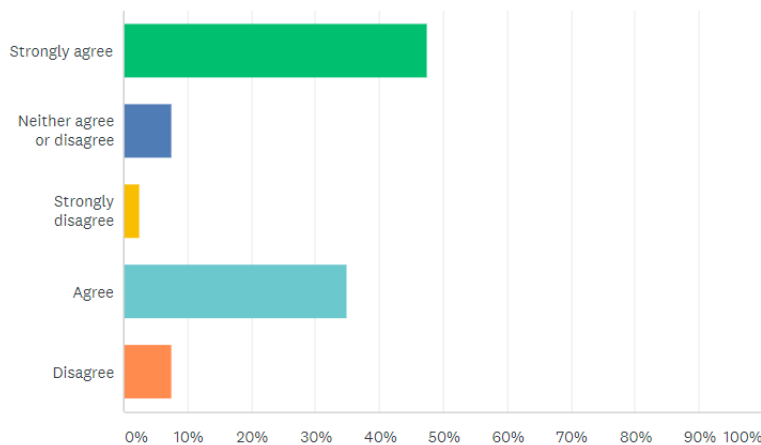

My child received an appropriate amount of work to complete at home.

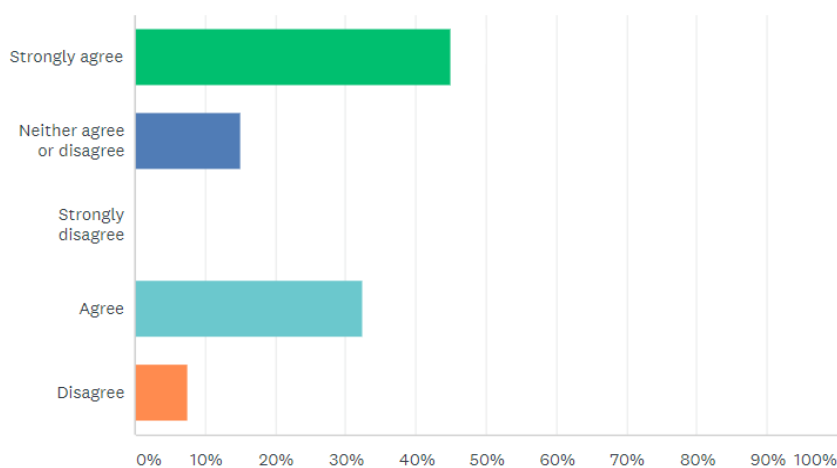

My child received useful feedback.

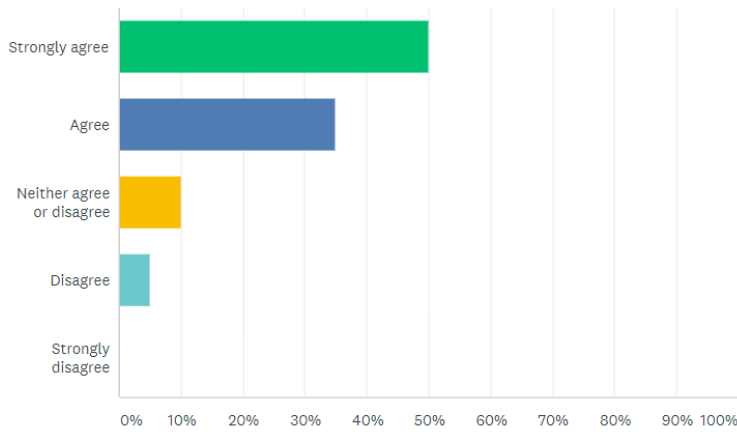

The teaching staff were available to support children's learning at home.

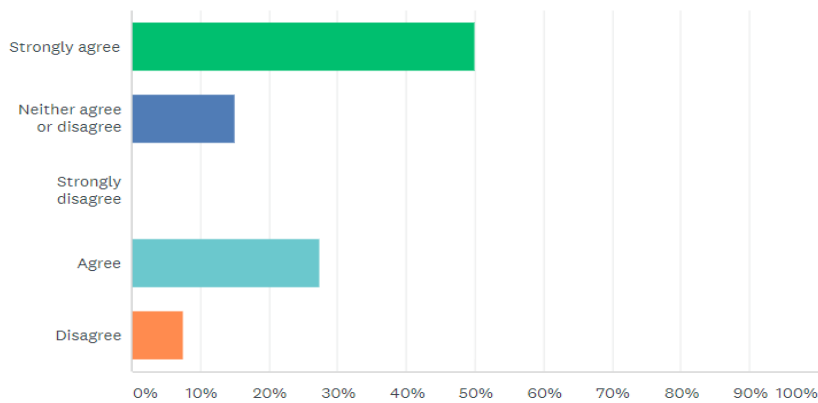

The school responds well to any concerns I raised.

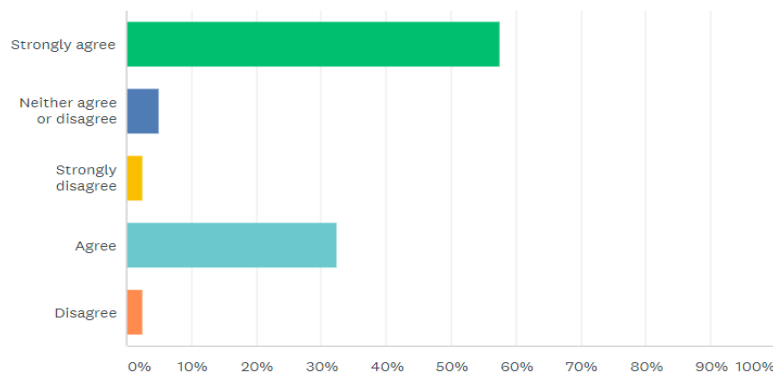

Communication between home and school was good.

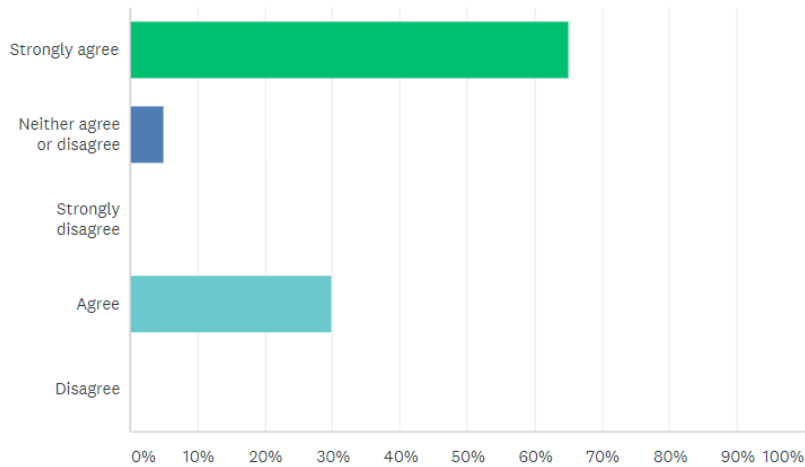

There was a range of subject coverage during remote education.

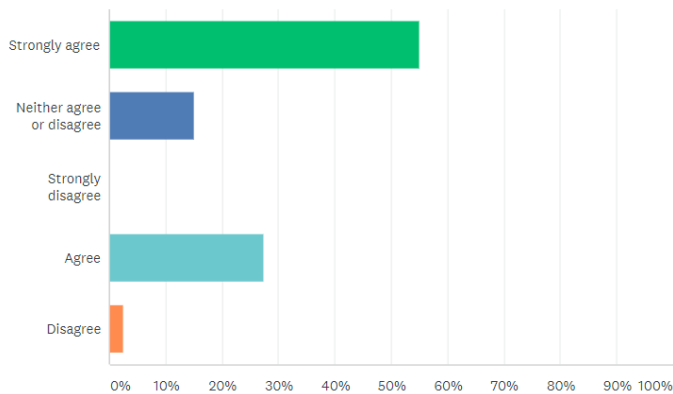
